FFA Clark County Fair Rules

- Eligibility:** All FFA members in good standing in a Clark County FFA Chapter are eligible to show in the FFA Division of the Clark County Fair, provided they have not passed their 19th birthday by January 1st of the current year or are completing their senior year in high school.
- Entries:**
 - Entries in the FFA Division of the 2025 Clark County Fair **close on May 31**. No late entries accepted!
 - Each FFA member must make **non-market livestock entries no later than May 31st** on-line using Fair Entry at <http://clarkohjrfair.fairentry.com>. **FFA members must create their on-line Fair entry profile by May 15 for Fair management to be able to make entries for market livestock projects.**
 - Non-animal entry check-in at the Youth Building: **Fri., July 18, 5 PM-9 PM and Sat., July 19, 8 AM-10 AM**
 - Non-animal entries released: **Fri., July 25, 2 PM-5 PM**. Entries not picked up will be disposed by the FFA Youth Building Department or returned to the local FFA advisor.
- Judging:** **FFA exhibitors of youth building projects are NOT REQUIRED to be present for judging. All Youth Building Projects will be judged and graded by the end of the day on Sunday of fair week.**
- Awards and Premiums:** Premiums will be awarded for all A, B and C rated projects as listed under each FFA division. Premiums will be awarded to all 1st and 2nd place **(and 3rd, 4th & 5th, where applicable)** exhibitors in addition to the premium earned from the judge's grade. Exhibitors will receive grade ribbons based on earning A, B or C and 1st and 2nd place (and 3rd, 4th & 5th, where applicable) will receive rosettes. **Premiums must be picked up by exhibitors at the fair office no later than the last Friday of August or else the exhibitor will forfeit premium earnings.**
- Care of Livestock & Pens:** All livestock projects and pens must be clean throughout the duration of the fair. The pen must be cleaned during specified times by each species no later than the close of fair. If these rules are violated a \$20.00 fee will be assessed to clean the pen and the exhibitor's auction check withheld until paid.
- Rule Violation:** Continued violation of rules may result in exclusion from FFA divisions in future years.

FFA Code of Ethics

We will conduct ourselves to be a credit to our organization, chapter, school, and community by:

- Dressing neatly and appropriately for the occasion.
- Showing respect for the rights of others and always being courteous.
- Being honest and not taking unfair advantage of others.
- Respecting the property of others.
- Refraining from loud, boisterous talk, swearing and other unbecoming conduct.
- Demonstrating sportsmanship in the show ring and being modest in winning and generous in defeat.
- Attending meetings promptly and respecting the opinion of others in discussion.
- Taking pride in our organization, activities, supervised experience programs, exhibits, & the occupation of ag.
- Not possessing or consuming alcohol, tobacco products or illegal drugs.
- Sharing with others experiences and knowledge gained by attending national and state meetings.
- Any violations of these ethics may result in disciplinary action by the FFA Advisor, including possible disqualification from the FFA activities.

Behavior and Disciplinary Action:

1. FFA exhibitors are representing the FFA organization while exhibiting in the Clark County Junior Fair. FFA exhibitors are required to abide by the FFA Code of Ethics.
2. Anyone under age 21 may not possess or consume Alcohol or liquor in any public or private place in the State of Ohio. The Fair Management will be enforcing this law aggressively at the Clark County Fair.
3. Any Jr. Fair exhibitor, charged by the Clark County Sheriff's Office with any offense including but not limited to, any alcohol offense, unruly behavior, or disorderly conduct, while on the Clark County Fairgrounds will be subject to disciplinary action that will include the disqualification and removal from the grounds of their Jr. Fair project(s).

Any premiums will be forfeited including monies received over and above the resale value of any livestock sold. The Exhibitor will not be permitted to take part in any further Jr. Fair activities during the balance of the fair with the possibility of affecting future participation. **Exhibitors may also be subject to discipline by their local school district, superintendent, principal or athletic director.** This rule applies for the entire Fair Week, begins Thursday, July 17 midnight to Saturday, July 26 noon.

Rules and Regulations:

1. Entry Requirements:

- A. Exhibitor must exhibit one or more animals per class during the respective shows at the Clark County Fair.
- B. Exhibitor must make entry by May 31 and meet all other exhibition and entry requirements for the animal(s) being exhibited. See specific exhibition requirement under each species department.

2. Premiums: Premiums awarded based on project being on exhibit not per animal on exhibit. **Premiums must be picked up by the exhibitors at the fair office no later than the last Friday of August or else the exhibitor will forfeit premium earnings.**

* Market animals will not receive a premium due to the high price received through the Junior Fair Auction that includes any member that also sells Dairy Milk, Goat Milk or Egg Production.

Rules and Regulations:

1. Entry Requirements:

- A. An exhibitor may enter ONE wood lathe and/or ONE wood skill board and up to TWO entries per wood class size (small, medium, large) ONLY.
- B. Entries must be constructed during the current school year under the direct supervision of the agri-science instructor.
- C. Each exhibit must be labeled to show the following: Student's Name, School Name, Project Name
- D. The FFA instructors in charge will make the final decision on proper classes if any are in question.
- E. Entries must be in place by 10 AM, First Saturday of Fair. Entries must remain on display all week.

2. Criteria: Projects will be judged on the following basis:

Construction & Workmanship 70%

Material and Display 10%

Practicality and Usefulness 20%

- A. Judges will not discriminate against exhibit use if it has been reasonably cleaned up for display.

Rules and Regulations:

1. Entry Requirements:

- A. An exhibitor may enter as many different classes as he/she desires but is limited to one entry per class.
- B. Entries **must be** constructed during the current school year under the direct supervision of the agriculture Instructor.
- C. Each exhibit must be labeled to show the following: Student's Name, School Name, Project Name
- D. The FFA **instructors** in charge will make the final decision on proper classes if any are in question.
- E. Entries must be in place by 10 AM, First Saturday of Fair. Entries must remain on display all week.

2. Judging Criteria:

- A. Projects will be judged on the following basis:
 - Construction and Workmanship 70%
 - Material and Display 10%
 - Practicality and Usefulness 20%**
- B. Judges will not discriminate against exhibit use if it has been reasonably cleaned up for display.
- C. All projects must NOT have been previously exhibited at the Clark County Fair and must be an original item.**

3. Additional Restoration & Reconditioning Project Rules & Details (Classes 55, 60 & 65):

- A. The actual item must be brought to the fair and be on display for all of fair week (from drop-off to pick-up, as stated in items C & D on page 1 of this document). Display boards, albums and pictures by themselves will not be accepted without the actual restored/reconditioned project itself displayed in the youth building.**
- B. It is REQUIRED that a notebook, album, poster board (or other means of display) with images of the item in its original condition, work in progress and final outcome accompanies the project.**
- C. Please let your FFA advisor know if you will exhibit a larger project (such as a tractor or hay wagon). It is highly recommended that larger projects be brought to the Youth Building by noon on the Thursday before fair week starts. This will ensure that there is plenty of space and room before all other items come in the next couple of days.**
- D. It is highly recommended that tractors and larger restoration projects be secured by putting cones and/or rope (or other similar materials) around it to keep fairgoers at a safe distance away from the project. Materials for securing the project must be provided by the exhibitor.**

Rules and Regulations:

1. Entry Requirements:

- A. An individual may only make one entry in each class.
- B. Exhibit should include only one photograph in a frame. (frame will NOT be part of judging or scoring).
- C. Exhibit should clearly fit the class category for which it was entered.
- D. The size of print shall only be 5" x 7" in size.
- E. Photographs taken by professional photographers shall not be included in these exhibits. Students should NOT appear in photos unless self-taken (on a timer, "selfie", etc.)
- F. Entries must be in place by 10 AM, First Saturday of Fair.

2. Judging Criteria: Photographs will be judged on the following basis:

- A. General Appearance and Power to Attract Attention of the Photograph
- B. Development of a Central Thought or Idea.
- C. Pictorial and photographic quality of individual print.
- D. Photo in any class can be of any type (black & white, color, sepia, mosaic, etc.) to express creativity or photographic effect.
- E. Exhibits are not to be disqualified unless deemed inappropriate or completely off-base.

Rules and Regulations:

1. Entry Requirements:

- A. All shelled grain exhibited in clean one-gallon glass jars, free of chaff and foreign matter.
- B. FFA members are limited to one entry per class.
- C. Entries must be in place by 10 AM, First Saturday of Fair.
- D. Members exhibiting corn (3 stalks) must display their corn stalks in a 5-gallon bucket inside the Youth Building
- E. The exhibitor must have grown the exhibit during the current crop year, except for shelled corn and grain soybeans that may be from the previous crop year. Old grain will not be graded.
- F. Identify variety for crop **or product** entered.
- G. **All exhibits should be clean and made presentable to the public.** Exposed roots shall be clean and free from mud and soil clods (with exception of growing corn in buckets). Leaves, stems, shoots and pods/cobs/seed panicles shall be clean and presentable.

H. Raw Wool & Animal Fiber Entries:

- i. **It is recommended that exhibitors pack fleeces in a clear plastic bag rather loosely so as not to impair their character or attractiveness.**
- ii. **Fleeces entered should have been shorn in the last 12 months prior to the fair. The wool should represent no more than 12 months growth except in the case of yearling fleeces, when 16 months growth will be allowed.**

*Disqualification only if **the product** is exhibited in the incorrect class or blatant violation of entry requirements or rules.
